

**Higher Education Emergency Relief Fund (HEERF) Reporting – Student Aid Funds  
(Quarter ending March 31, 2022)**

*Quarterly Report Covering ARP (HEERF III) Student Aid Fund Expenditures*

The Federal Government has provided emergency relief funds to colleges, including Suffolk County Community College, through legislation such as the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA), and the American Rescue Plan (ARP). These relief funds are categorized as the HEERF I (under the Cares Act), HEERF II (under CRRSAA), and HEERF III (under ARP) to continue support for institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic. A portion of these funds are to be used to provide emergency financial assistance to students.

Suffolk County Community College has been allocated HEERF Student Aid Funds to provide emergency grants to students experiencing financial hardship due to the COVID-19 pandemic for expenses related to any component of the student’s cost of attendance and/or for emergency costs that arise due to coronavirus.

As a recipient of HEERF Student Aid Funds, Suffolk County Community College is required by the U.S. Department of Education to report the following elements on a quarterly basis:

1. An acknowledgment that the certification agreement was signed and returned to the U.S. Department of Education and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) programs to provide Emergency Financial Aid Grants to students.
2. The total amount of funds the institution will receive or has received from the Department of Education pursuant to the institution’s Certification and Agreement for Financial Aid Grants to students under the CRRSAA and ARP (a)(1) programs.
3. The total amount of emergency grants distributed to students.
4. The estimated total number of students eligible to receive an emergency grant.
5. The total number of students who received an emergency grant.
6. The method the institution used to determine which students will receive emergency grants and how much funding they will receive.
7. Any instructions, directions, or guidance provided by the institution to students concerning the emergency grants.

***ARP HEERF III Emergency Financial Aid Grants to Students***

Suffolk County Community College received Student Aid funding under Section 2003(7) of the ARP. This program, with some changes, provides supplemental funds to the CARES Act Section 18004(a)(1) program. Suffolk County Community College signed and returned to the U.S. Department of Education a Certification and Agreement as required under the CARES Act Section 18004(a)(1) program. We acknowledge that by drawing down the ARP funds, our institution agrees to be bound by the conditions set forth in the ARP Supplemental Agreement, including using 100% of these funds to provide emergency financial aid grants to students.

Suffolk County Community College has received or will receive \$22,747,465 from the Department of Education in Student Aid funding under the ARP Section 2003(7) program.

Suffolk County Community College has distributed \$18,432,676.50 under the ARP Section 2003(7) program as of March 31, 2022.

Suffolk County Community College has determined that approximately 5605 students, based on the number of students enrolled in the Spring 2022 semester with expected family contributions ranging from \$0 to \$14,615 were eligible to receive Priority 1 Emergency Financial Aid Grants under the ARP Section 2003(7) program, utilizing the State University of New York (SUNY)'s formula for prioritizing students with demonstrated exceptional need. Other students are potentially eligible for award with remaining funds, if they have demonstrated need.

5564 students have received Emergency Financial Aid Grants to students under the ARP Section 2003(7) program as of March 31, 2022. Students received first round Emergency Financial Aid Priority 1 grants utilizing SUNY's formula for prioritizing students with Pell-eligible expected family contributions who were enrolled during the Spring 2022 semester. During this quarter, 41 student received Emergency Financial Aid grants with ARP Section 2003(7) funds based on exceptional need. Under ARP Section 2003 (7) program, students thus far have received average awards of \$1,250.

Additional Grants: Thereafter, additional students who did not receive Priority 1 grants but who were otherwise eligible under the ARP Section 2003(7) program and who were identified as having exceptional need by Financial Aid (including based on NYS need-based aid eligibility) received awards. This included Advanced Manufacturing and Training Students and the Tesla Automotive Program, and other students who requested assistance to cover outstanding balances, costs related to components of the student's cost of attendance, and for emergency costs that arose due to coronavirus such as tuition & fees, transportation, housing, medical and childcare costs. Awards were based upon enrollment status and demonstrated need.

Suffolk County Community College has prioritized awarding of Emergency Financial Aid Grants under the ARP Section 2003(7) program to its students in the following manner (awarding methodology):

Priority 1 (based on eligible expected family contributions): Students enrolled during the Spring 2022 semester with expected family contributions ranging from \$0 to \$14,615 were identified to receive Priority 1 grants utilizing SUNY's formula. Award amount was based on the EFC range and the student's full-time / part-time status, as delineated below:

We have approximately \$4,314,788.50 in ARP funds to distribute to students with exceptional need as the result of the COVID-19 pandemic. The college developed an online application for students to complete if they had expenses related to the COVID-19 pandemic. The online application had a soft launch on April 1, 2022.
