SUBJECT:    County Offers Mobile COVID-19 Rapid Testing to Employees/Retirees and Dependents

Suffolk County has extended its weekly schedule for drive-through COVID-19 Rapid Tests free of charge to Suffolk County employees, their dependents and retirees.

Over the past six weeks, the Rapid COVID-19 testing program has administered over 4,000 rapid tests to Suffolk County employees, their families and retirees. Because of the success of this program, the County is extending this testing through the end of February. The County has expanded its partnership with Baseline Health to offer weekly mobile rapid COVID-19 tests, free of charge, to County employees, retirees and their dependents.

Testing will continue to operate at Smith Point County Park every Saturday through February from 8 a.m. to 4 p.m. No appointment is necessary and employees/retirees and their dependents will be tested in their vehicles. Testing at this site is exclusively available to employees/retirees, who must present either their employee identification card, a paystub, or a Suffolk EMHP insurance card. Employees/retirees must accompany their dependents who are interested in receiving this benefit.

In addition, on Tuesdays, through February, Baseline Health will be operating another drive-thru testing site(s) at a variety of locations across the County. The sites are noted below and will be operational from 10 a.m. to 6 p.m. This is also mobile rapid COVID-19 tests, free of charge to County employees/retirees and their dependents. No appointments are necessary to access this benefit. Testing at these sites are exclusively available to employees/retirees and their dependents, who must present either their employee identification card, a paystub, or a Suffolk EMHP insurance card in order to gain access to the testing site. Employees/retirees must accompany their dependents who are interested in receiving this benefit.
